LUBES FOR GRAMP OF MARRIAGE ALLOWANCE TOWARDS MARRIAGE OF DAUGHTER OF DESTITUTE WID CWS.

1. Short titlo: These Rules shall be called "Rules for grant of marriage grant for the marriage of daughters of destitute widows".

23, Definition: In these rules, unless the context otherwise requires:

(n) Department means the Department of Social Welfare;

(h) "Estitute Widow" means a widow whose annual income from all sources including the income of the daughter does not exceed Rs. (1,500/ per annum;

(c) Form means a form appended to these rules;

(1) 'Covernment' means the Administrator of Pordicher y appointed under Article-237 of the Constitution of India.

3. Objects: It is generally found that destitute wid ws find it extremely difficult to arrange for the marriage of their daughters with the result that such daughters are driven to desperation and certain extreme conditions like noral degeneration, suicides, etc. The aid of these rules is to give marriage allowance to such widows so that they will be in a position to arrange the marriage of their daughters.

4. Eligibility:

(i) The destitute widow shall not have any financial support, either from sbooks ! her husband's side or parent's side.

(ii) The income from all sources shall not exceed Rs. (1,500/- per a num. This includes the income of the proposed bride also.

(iii) She should produce a certificate to the effect that she is a destitute widow.

(iv) She should be citizen of India and a native of the Union Territory of Pondicherry by birth or by continuous residence of 5 years and more. A person who claims nativity by virtue of birth but has not resided in the Union Territory for a continuous period of at least 3 years on the date of application is not eligible for the allowance.

(v) She should be prepared to give an undertaking in the prescribed form to the effect that the amount of marriage allowance (runted will be utilised only towards the expenses of the marriage and not for any other purpose.

(vi) The marriage should be maintainable in accordance with the law. (vii) The allowance is payable only for the marriage solomnised for the first

time in respect of the bride. (viii) The allowance is given for the penformance of carriage of one daughter only.

5. Amount of Allowance: The ampunt of allowance, that may be granted under these rules shall not exceed Rs (1,000/-(Rupees one thousand only).

6. Making of Application:

(i) The application for grant of allowance under these rules shall be submitted to the Director of Social Welfare, Ponlicherry, at least 30 days before the date of the proposed marriage. However, the time time to be submitted in Form-I accompanied by the

following certificates namely:-(a) Income and Nativity Certificate in Form-II as detailed in Section-4(ii) aml 4(iv) above obtained from an officer of the Revenue Department not below the rank of a Deputy Tahildar.

(b) A certificate in Form-III from a Member of Parliament or a Member of the Terislative Assembly or the Commissioner of the Municipality/

7. Scrutiny of application:

1. The Director of Social Welfare, Pondicherry, on receipt application shall recommend the same to Government for sanction satisfying himself/that--

(a) the marriage is genuine.

(b) the marriage is legal in all respects.
(c) the services of the District, Probation Officer may be utilised in optaining the above particulars.
